#### **ANNEX**

#### GENERAL CONDITIONS AND PRICING

### SUPPLY AND DISTRIBUTION OF WATER AND SANITATION OF WASTEWATER

The information listed in the following clauses does not waiver the close reading of the Regulations of the Water and Wastewater Sanitation Supply / Distribution System of the Municipality of Arganil (Regulation no. 702/2019, published in the II Series of the Official Gazette, no. 170, of 5 September 2019).

### Clause I - Managing Entity

- 1 The managing entity of the public system is the Municipality of Arganil.
- 2 It is up to the managing entity:
  - a) To supply drinking water for domestic, commercial and industrial consumption to all buildings situated in the geographical area of the municipality, served by the public distribution system;
  - b) To take responsibility for the planning, construction, operation and maintenance of water supply and wastewater sanitation systems;
  - c) To assure the maximum benefit of the public water supply and wastewater sanitation service;
  - d) To establish an overall relationship with users that respects the guiding principles of the public service provision;
  - e) To enforce the provisions of the Municipal Regulations in force, as well as all legislation on these matters;
  - f) To maintain the system in good working order and condition;
  - g) To subject the system components, before being put into force, to tests to ensure that the work carried out is perfect;
  - h) To ensure the continuity of service, except in case of scheduled works or unforeseen circumstances, when immediate measures must be taken to deal with that situation and, in any event, with an obligation to warn users;
  - i) To promote the installation, replacement or renewal of connecting lines;
  - j) To establish outdoor plumbing, which shall become its property.

### Clause II - Rights and duties of users

- 1. In particular, users shall benefit from the following rights:
  - a) The proper overall functioning of water supply and wastewater sanitation systems;
  - b) The preservation of safety and public health;
  - c) Information on all aspects of the public water supply and wastewater sanitation service and the data essential for the proper execution of projects and works on land sanitation systems;
  - d) To request inspections;

e) To complain about the acts and omissions of the Municipality of Arganil that may prejudice their legally protected rights or interests.



## 2. Users have the following duties:

- a) To comply with the provisions of the Municipal Regulations in force and complementary rules, to the extent applicable to them, and comply with the instructions and recommendations of the Municipality of Arganil;
- b) To make proper use of building sanitation systems;
- c) To keep sanitary appliances and devices in good working order;
- d) To not make connections to the wastewater sanitation system without prior authorization from the Municipality of Arganil;
- e) To not change the connecting branch;
- f) To not misuse the water supply and wastewater sanitation systems, nor damage any of their component parts;
- g) To notify the Municipality of Arganil of any malfunctions related to the water distribution and wastewater sanitation system;
- h) To pay on time and in full the sums due for the provision of contracted services;
- i) To cooperate with the Municipality of Arganil to ensure the proper functioning of water supply and wastewater sanitation systems;
- j) To notify the Municipality of Arganil at least five business days in advance of the date on which the user definitively leaves their home. Failure to comply with this obligation implies in the user's responsibility for any resulting charges;
- I) To comply with the provisions of the Municipal Regulations in force.

## Clause III - Continuity of the service

- 1 The public water distribution and wastewater sanitation systems are in service without interruption, except in fortuitous and force majeure cases, such as malfunctions, accidents, obstruction, leakage, power outages or remodeling in any body of the system.
- 2 Network users shall not be entitled to receive any compensation for damage or inconvenience resulting from deficiencies or interruptions in public water distribution and wastewater sanitation systems, due to force majeure and also due to carelessness, defects or malfunctions in private facilities.
- 3 In the case of works on public water distribution and wastewater sanitation systems, which are not urgent and imply service interruptions, the Municipality of Arganil will, whenever possible, give prior and public notice to the users of the systems in question.
- 4 It is up to the users to take, in all cases, the necessary measures to mitigate, eliminate or avoid disturbances, emerging damages or accidents during the execution of the works, so that they can be carried out in good conditions and as quickly as possible.

#### Clause IV – Termination of contract

- 1 The termination of the contract must be notified to the Municipality of Arganil at least five business days before the respective effective date.
- 2 The non-compliance of the obligation to pay the invoicing of the service provided under this contract will imply the termination of the contract.

Clause V - Meters

The meters are installed in a location chosen by the services of the Municipality of Arganil, accessible to an easy and regular reading, with adequate protection for their efficient maintenance and normal operation, complying with the conditions set forth by the Municipal Regulations in force, and may not be changed in any circumstances by the consumer.

Clause VI – Suspension of water supply

The water supply may be suspended in the cases expressly foreseen in the Municipal Regulations in force.

Clause VII – Prices, invoicing and payments

The invoicing and payment conditions for the services contracted herein, as well as the respective prices charged, are those laid down in the Municipal Regulations in force and included in the attached price list.

**URBAN SOLID WASTE** 

All users of the Municipality of Arganil, producers or holders of waste, are covered by the Urban Solid Waste Management System, as defined in the Regulation of the Urban Waste Management Service of the Municipality of Arganil (Regulation no. 702/2019, published in the II Series of the Official Gazette, no. 170, of 5 September 2019), and must comply with the regulations contained therein and pay the costs listed in the attached price list.
