#### Opening remarks

The Arganil Welcome Guide is the result of the Arganil + Migration project, co-funded by the Asylum, Migration and Integration Fund (FAMI). This guide is an instrument for facilitating and promoting the integration of and participation by the migrant population, resident or recently arrived (focusing particularly on national citizens from third countries) in the local communities in our municipality. In recent decades, Arganil has seen a significant increase in the foreign community in the municipality, making it necessary to introduce a simplified support mechanism with all of the information and quidelines on the social action areas and their operation. With the preparation of the 2020-2023 Arganil Municipal Plan for the Integration of Migrants, presented in November 2020, this guide contains clear and objective information on the services, the private social solidarity institutions / charitable institutions in the municipality and the public bodies that can provide support to migrants in the areas of local administration, education and training, health, justice and safety, employment and vocational training, social inclusion and support and legalisation. The different municipal entities referred to here provided valuable support in the preparation of this guide. This is a particularly useful and advantageous instrument, reinforcing the value of intercultural diversity and the importance of the integration of migrant communities into integrated and sustained local development.

We are now presenting the second edition of this guide, revised and updated.

#### 1.1. Description of Arganil Municipality

Arganil Municipality is an administrative part of Coimbra District and in terms of land planning it is part of the Coimbra Intermunicipal Community Region and the Pinhal Interior Norte Subregion. Arganil Municipality has an area of 332.13 km2, which is subdivided into 14 parishes and 178 localities. The average altitude is 516 m. It has a population of 11,068 and a working-age population of 56.6%. Its population density is 33.2 people/km2 (2021 Census).

#### **Arganil Municipality**

The duties of Arganil Municipality are to promote and safeguard the interests of the different people living here. In conjunction with the parishes, it has the power to take action in the following areas: a) Rural and urban equipment; b) Energy: c) Transport and communications; d) Education, teaching and vocational training; e) Heritage, culture and science; f) Free time activities and sport; g) Health; h) Social Action; i) Housing; j) Civil defence; k) Environment and basic sanitation; l) Consumer protection; m) Promoting development; n) Rural and urban planning; o) Municipal police; p) External cooperation.



CLAIM provides general information about legalisation, nationality, family

reunification, housing, voluntary return, work, health and education, as well as other areas for all foreign citizens from the European Union or third countries. Here, foreign citizens (or family members accompanying them or being reunited with them) from the European Union or the European Economic Area and Switzerland or foreign citizens with Portuguese relatives may also request the issue of an EU registration certificate. This certificate is required for foreign citizens who intend to reside in Portugal for longer than three months.

### **DECO – Portuguese Consumer Protection Association**

#### 3. EDUCATION

The right to education and equal access opportunities and school success is enshrined in Article 74 of the **Portuguese Constitution**.

More specifically, the Portuguese legislation in force states that all foreign children aged between 6 and 18 shall have full access to education, with the right to attend school, even if they are in an irregular situation in the country. In these cases, access to education is assured through the national register of foreign minors in an irregular situation in the country, on request from any public administration service or on request of the parent or quardian. The law also provides for assuring adequate support for the enforcement to the right to education for the children of immigrants resident in our country.

3.1. Stages and Types of Schooling in the Portuguese Education System In Portugal, all children aged between 6 and 18 must go to school (irrespective of the education level reached). This obligation may end on conclusion of the 12th year of schooling or on obtaining a certificate confirming the secondary education level.

### Stages of the Portuguese Educational System

**Preschool education:** from the 3 until beginning primary school. This education level is optional.

Basic education: this education level lasts for nine years and is subdivided into three sequential cycles: 1st cycle (4 years, from 1st to 4th year), 2nd cycle (2 years, 5th and 6th years) and 3rd cycle (3 years, from 7th to 9th year).

There are two teaching options in basic education: general basic education and specialised artistic courses (where the artistic component is reinforced in order to allow the pupils to learn about specific areas, particularly dance, music or Gregorian chant).

The Arganil School Cluster provides specialised artistic training in the area of music for 5th to 8th year pupils, which is assured through a partnership with the Coimbra Music Conservatory and Arganil Municipality and is free for the pupils who choose this area.

For pupils who have not had Portuguese as a subject or whose mother tongue is not Portuguese, the curriculum for general basic education or specialised artistic courses includes Portuguese as a Non-Native Language (PLNM). This component is aimed at making it possible to develop the essential skills for full inclusion in school curricular activities.

Secondary Education: comprises three years of schooling (from 10th to 12th year)

This level of education is aimed at pupils wishing to continue their studies and/or join the labour market. The education and training areas available are as follows (these may vary according to the school attended)

- Scientific and Humanities Courses:
  Aimed mainly at going on to third level
  education, there are four options here:
  Science and Technology Course;
  Socioeconomic Sciences Course;
  Languages and Humanities Course
  and Visual Arts Course.
- Specialised Artistic Courses: these courses have two main aims, integration into the labour market and/or continued studies (visual and audiovisual arts and dance).
- Vocational Courses: aimed mainly at learning the skills needed for engaging in a profession, but which also allow for continued studies (post-secondary training or higher education).
- Scientific and Technological Courses: these consist mainly of dual certification, with solid scientific and technological components.

Scientific and humanities courses and specialised artistic courses may include **Portuguese as a Non-Native Language** as a subject under the conditions referred to above.

Basic and secondary education may also include education and training courses for young people and, in the situations specifically provided for by law, the integrated education and training programme and the possibility of redirecting the education route of the pupil.

### Non-University Post-Secondary Education:

Technological Specialisation Courses (CET) make it possible to gain a scientific or technological specialisation in a certain training area and are available for pupils who have completed secondary school or that have legally equivalent qualifications.

University and Polytechnic Education: Higher Education consists of university and polytechnic education and is structured according to the Bologna principles. There are no universities or polytechnics in Arganil Municipality. The closest ones are in Coimbra, Oliveira do Hospital and Viseu.

#### Types of Schooling in Portugal

In-person schooling: pupils are taught in the school they are enrolled in.

Education for Itinerant Pupils: an education and training response for the children of itinerant workers who travel around from place to place. They go to different schools throughout the school year for longer or shorter periods during their time at school.

Home Schooling: the pupil is taught in their own home by a family member or somebody living with them;

Individual Tuition: the pupil is taught by a qualified teacher outside of the school.

Home schooling and individual tuition are governed by Decree-Law No. 70/2021, of 3 August. For further information, please go to the main school in the Arganil School Cluster.

#### Useful Information about the Public School Network

In Portugal, public school education is free during the entire compulsory education period.

#### How can I enrol my child?

For public schools, parents or quardians that have citizen's cards (as well as the PIN and a card reader) can enrol their child at Portal das Escolas [www.portaldasescolas.pt]. If this is not the case, they should go to the main school in the school cluster in their area of residence and enrol their child through the school administrative services.

Parents or quardians may also choose to enrol their child in a private or cooperative school or in another educational institution, provided that this is recognised by the competent authorities (Ministry of Education).

#### What documents are needed for enrolling a pupil in the public education network?

- Identification document for the child: identity card or birth certificate, or national register of minors;
- Portuguese National Health Service (SNS) user number:
- SNS health card number or beneficiary number, the identification of the entity and the health subsystem number, if applicable;
- Tax number, if any;

- Social security number (NISS) for **3.2.1. Kindergartens | Primary** pupils who are beneficiaries of children's allowance paid by social security:
- Proof of residence:
- Proof of the address of the parent or quardian's place of work;
- If the child has attended school in their country of origin, a certificate of qualifications. translated into Portuguese and authenticated (by the country's consulate or embassy in Portugal or the Portuguese consulate or embassy in that country) or the Haque Apostille. A certificate of equivalence should then be requested from the principal of the school in the area of residence or where the child is to be enrolled (primary, middle or secondary school);
- Information on the composition of the household validated by the Tax Authority, only when the one of the parents is not the child's quardian.

# 3.3. School Social Action and Other Social Responses in the Education Area

**3.3.1.** Under the scope of the **powers** and duties of Arganil Municipality, School Social Action is a measure aimed at promoting and assuring equal opportunity school access and success. The socio-educational support available is aimed at children and pupils from

households whose economic situation determines the need for this support in order to help them make ends meet. This support should be requested from the **Arganil One-Stop** Shop and can cover the following areas:

#### Provision of School Meals

(Lunches and snacks): Public kindergartens and primary schools – Category 1 pupils (free), Category 2 pupils (half price).

(Lunches): Arganil and Côja Middle Schools and Arganil Secondary School

- Workbooks: Public primary schools Category 1 pupils (free), Category 2 pupils (half price).
- School Transport: free for all pupils in all education and teaching levels resident in Arganil Municipality and payment of 50% for pupils living outside the municipality and pupils with permanent special education needs with an individual educational programme when travelling to the reference schools or to other structured teaching and specialised support units they attend.
- Entertainment and Family Support Activities (AAAF): this is a social and educational response aimed at meeting the needs of families and the children that go to public kindergartens. - **3.3.3.** The Ministry of Education provides the following support in the area of school social action (attributed based on the positioning in the income brackets for the attribution of children's allowance paid by social security). This support should be requested at the main school in the school cluster:
- •School milk: free to all children attending public kindergartens and primary schools:
- •School Insurance: for children/pupils attending public kindergartens and primary, middle and secondary schools.
- •Accommodation: for pupils who cannot stay in their homes while attending school when it is not possible to assure alternative school transport.

- •Schoolbooks: free for pupils doing their compulsory schooling in public schools. To get them, the parent or guardian has to register on the online platform (https://manuaisescolares.pt/) and/or the mobile app (Edu Rede Escolar) (your tax number will be requested) and use the vouchers issued.
- •Merit Scholarship: for outstanding students.



#### 4. HEALTH

#### 4.1. Right to Good Health

According to the legislation in force, any migrant who feels ill or is in need of any other type of healthcare is entitled to go to a health centre or hospital for care. Access may not be refused or limited based on reasons of nationality, racial or ethnic origin, legal status, parentage or country of origin.

### What is the Portuguese National Health Service (SNS)?

The SNS consists of a network of institutions and services providing overall healthcare to the entire population, through which the state, and the Ministry of Health in particular, safeguards the right to health protection.

According to the legislation in force, the healthcare services provided by the SNS are universal and largely free of charge. All that is required is the payment of a small sum (basic fee -TM) per consultation or healthcare service provided. However, bearing in mind the economic and social situation of the users, several situations are exempt from payment of the TM, such as pregnant women, new mothers and family planning consultations, children aged up to 18. unemployed persons registered at the Employment Centre, people with certain chronic diseases or chronic diseases or chronic mental illness, as

well as other situations specified in the law.

Also through the SNS, the state pays part of the price of medicine (according to different income brackets) and provides for refunding the cost of certain equipment (prosthetics, glasses, frames, lenses and orthopaedic footwear) when proof of these expenses is presented, within 180 days of the date the payment was made and when accompanied by a prescription issued by the family doctor at the Health Centre.

#### What is a Health Centre (CS)?

This is the basic SNS unit for serving and providing essential healthcare, preventive or curative, to the population.

The services provided by the CS include:

- General/family medicine consultations; maternal health / family planning; infant and child health
- Diabetes consultations
- Public health service (health delegate);
- Nursing care:
- Social service:
- Vaccinations:
- Auxiliary diagnostic tests;
- Home consultations and support In order to use these services, citizens must register at the Health Centre in their area of residence.

Primary healthcare services are provided to citizens resident in Arganil Municipal by the Pinhal Interior Norte

Health Centre Cluster (ACES PIN) and, more specifically, by the Arganil Health Centre.

In life threatening or emergency situations, patients may be sent to a hospital emergency service. Patients may also be sent to hospital via their family doctor when the need arises for specialty consultations that are not available in the Health Centre.

### How can I register at my local Health Centre?

### Citizens from a European Union country

For registration, you will need:

- Certificate of Registration of European Union Citizens (CRCUE) or a valid Residence Permit;
- Identification document (if you have a CRCUE);
- Proof of residence if it is not on the document;
- Tax number;
- Social security number (if any).

If you do not have a residence permit or your migrant status is irregular according to the legislation in force, you must present a document from your parish of residence certifying that you have been living in Portugal for more than 90 days.

This document should entitle you to a Certificate of Registration of European Union Citizens (CRCUE) at the One-Stop Shop in your area of residence or from the Immigration and Border Service (SEF). Registration at the Health Service provides access to healthcare services under the same conditions as Portuguese citizens and you will be given a National Health Service user number.

#### Citizens of Third Countries not part of the European Union, the European Economic Area or from Switzerland residing in Portugal

For registration, you will need:

- Valid residence card or visa (with proof that an appointment has been scheduled with SEF):
- Tax number:
- Social security number (if any);
- It is possible to present a document from a foreign financial authority.

In these cases, you will be given a National Health Service user number and access to the service will be under the same conditions as for Portuguese citizens.

Note: If you have been given a user number but your residence permit has expired (more than six months before) and you have not restarted the process at SEF, you should know that: - If you are from a country that has a health agreement with Portugal and you have a document substantiating this, you will only have to pay the basic fee

- If you are from a country without an agreement, you will have to pay the full cost of the care provided.

### What should I do if I'm only staying temporarily?

- Beneficiaries of agreements and/or conventions fall under the same category as Portuguese citizens.
  - o Citizens of European Union countries must present their European Health Insurance Card or Temporary Replacement Certificate and an identification document.
  - o Citizens of Andorra, Cape Verde, Canada/ Quebec, Morocco, Tunisia and Brazil must present a supporting document regarding the agreement between Portugal and their country of origin and an identification document.

Note: Citizens of third countries that do not have an agreement will have to pay the full cost of the healthcare provided. All that is required is an identification document (passport or other).

### What if I'm a citizen of a third country and I'm in an irregular situation?

If you have been living in Portugal for 90 days (but without a residence permit issued by SEF):

- You must present the certificate of residence issued by the Parish Council in the parish where you have been living in Portugal for over 90 days;
- Identification document; In these cases, you will have to pay the full cost of the healthcare provided.

There are exceptional situations where migrants (irregular or not) have access to healthcare under the same conditions as the general public:

- Urgent and vital healthcare;
- Contagious diseases that are a threat or danger to public health;
- Mother and child and reproductive healthcare (family planning, voluntary termination of pregnancy, monitoring pregnant women, childbirth, new mothers and healthcare provided to newborns);
- Healthcare for under 18s residing in Portugal (registering minors in an irregular situation in a database so they can benefit from access to healthcare);
- Vaccination:
- Foreign citizens in a family reunification situation when anybody in their household makes duly substantiated social security contributions;

- Citizens in a situation of social exclusion and/or economic deprivation, duly substantiated by the Social Security Service.

### 4.3. Solidarity Health Services in Arganil Municipality

Arganil Municipality also has Integrated Continued Care Units that are part of the National Integrated Continued Care Network and that are aimed at providing adequate healthcare and social support to everybody who, irrespective of their age, is in a situation of dependency. Referral to these services may be through a national health service hospital (if the patient is hospitalised there) or through a request addressed to the Family Health Unit (to the patient's family doctor or nurse or a social service officer) in the local health clinic if the patient is at home, in a private hospital or another institution or establishment. When necessary, and when certain criteria are met, there may be partial payment of the expenses by social security.

Continued Care Unit – Medium Term and Rehabilitation A social support response in the healthcare area for people who, following an acute illness or a flare-up of a chronic illness, have lost their autonomy and ability to function, but who can recover and require healthcare, functional rehabilitation and social support which, due to the complexity or duration, cannot be provided in the home and with a

prognosis of functional gains being achieved in up to 90 consecutive days.

#### How do I register?

You can register at the employment centre online (https://iefponline.ie-fp.pt/IEFP/index2.jsp) or in person at the employment service closest to where you live.

Some conditions must be met for registration, in particular you must: - Be available and fit for work;

- Be of minimum working age (16) and have completed compulsory schooling;

- Have your identification documents up to date:
- Identity card or citizen's card + social security card + tax number if you are a Portuguese citizen;
- Identity card or passport for foreign citizens if you are a citizen of a country in the European Economic Area;
- A certificate permitting residence in Portugal and enabling access to employment – if you are a citizen of a country outside the European Economic Area.

People requesting unemployment allowance must also prove that they are unemployed involuntarily, in other words the situation is not of their own choosing.

#### What is Centro Qualifica?

Arganil Municipality has two Centro Qualifica programmes whose main aim is to develop:

- Modular Training;

This is extremely important if you want to gain access to nationality, a permanent residence permit and/or long-term resident status (with level A2 certification).

#### Social responses:

Activities Centre and Training for Inclusion: a broad set of therapeutic responses, training and socially useful activities for people with serious or profound mental disabilities

Vocational Training: this includes a set of activities that promotes training and employability/inclusion in a normal job context for people with cognitive disabilities or other impairments.

Resources for Inclusion Centre (CRI): this has a team of people specialising in working with pupils with Special Educational Needs (NEE) - from the first year of primary school until the end of compulsory schooling. The Arganil School Cluster is a partner of the Coimbra APPACDM CRI.

Home Help Service: this is aimed at providing individual, personalised care in the home to people with disabilities or impairments and whose families are temporarily or permanently unable to help them in their daily activities

#### 7.4. Entities/Projects providing support for Senior Citizens

#### APPACDM - Arganil Functional Unit Arganil Municipality - 'Senior Sport' Programme

The Sports Office organises the 'Senior Sport' programme, which is aimed at planning and developing physical activities for senior citizens in a fun. educational context. This includes traditional Portuguese games and dances, exercises with balls, hula hoops, elastics and sticks, as well as other activities. The programme is developed in cooperation with private social solidarity institutions in the municipality and there is no cost for the users.

#### Arganil Municipality - 'Leitura das Memórias' project at the Miguel Torga Municipal Library in Arganil

This is a reading service that is held every month in care homes and day centres in the municipality and is aimed at improving literacy levels through reading, lending books and organising theme talks.

#### **Day Centre**

A social response that provides a set of services contributing to supporting people aged 65 and over in their social and family environment. Its goals include making it easier for senior citizens to continue with their usual way of life and contributing to delaying or avoiding their admittance to institutions as far as possible.

#### Home Help Service

A social response that consists of providing care and services to families and/or people who are in their own homes but are in a position of physical or mental dependency and who are unable, temporarily or permanently, to meet their basic needs and/or carry out the activities necessary to their daily lives and do not have any family support for the purpose. Its aims include allowing the people to remain in their usual living spaces, delaying or avoiding their being admitted to residential homes.

#### Residential Home for Senior Citizens

A social response aimed at temporary or permanent collective housing for senior citizens. This is aimed mainly at providing permanent and appropriate solutions for the biopsychosocial issues of senior citizens, contributing to the stimulation of an active ageing process and preserving/encouraging intrafamily relations.

# 7.5. Entities and Programmes supporting Families and the Community (Arganil Municipality)

#### 7.5.1. Service and Social Monitoring

Arganil Municipality is responsible for the Núcleo Local de Inserção de Arganil (NLI) [Local Integration Centre] and the Serviço de Atendimento e Acompanhamento Social no Concelho de Arganil (SAAS) [Social Assistance and Follow-up Service].

Decree-Law No. 55/2020 of 12 August, in its current wording, and in accordance with Ordinances No. 63/2021 and No. 65/2021 of 17 March. established the terms for the operationalisation of the transition of competences regarding the conclusion and monitoring integration contracts for beneficiaries of the Social Integration Income (RSI) and regarding the Social Assistance and Follow-up Service (SAAS), for the Municipal Councils, taking into account the provisions of paragraphs a) and f) of Article 3.1 and set out in Articles 10 and 11 of Decree-Law No. 55/2020 of 12 August.

#### What is the SAAS?

The SAAS consists of a first line service that seeks to respond to situations of crisis and/or social emergencies, as well as follow-up aimed at guaranteeing the permanent technical support, ensuring the implementation of the Social Integration Income (RSI)

measure and the operationalisation of the Social Assistance and Follow-up Service (SAAS), with a view to preventing and solving social problems.

#### What is the vision of the Arganil NLI?

The Arganil NLI aims to be a participatory forum for the promotion of social, professional and community integration of beneficiaries of the RSI and their families, as well as beneficiaries of Social Intervention Agreements (AIS), within the scope of Social Action, in conjunction with the resources and social responses in the community in a manner appropriate to the characteristics and needs of each beneficiary.

This forum promotes reflection on the problems, vulnerabilities, potential and local resources in the NLI's area of influence, in order to minimize and eradicate poverty and social exclusion.

1- The Arganil NLI must include a representative of the municipality, as well as a representative of each of the public entities responsible in the respective area: social security, employment and vocational training, education and health.

2- By deliberation of the NLI, public and private entities may also join the forum, if they do so of their own free will. Projects that develop activities with the same target population may join as well, through partnerships.

#### Geographical Scope

The NLI exercises its competence in

the Arganil Municipality, covering all the parishes and unions of parishes within the municipality.

#### How do I access the SAAS?

The service is available by appointment, by phone, online, or in person, any day of the week.

#### Social Action Office

Arganil Municipality has also a Social Action Office which provides services and social monitoring aimed at people and families living in a certain geographic area in the prevention and/or resolution of problems causing or caused by situations of social exclusion and, in certain cases, acting in situations of social emergency. It was set up in the municipality as a proximity structure, aimed at meeting the immediate needs of disadvantaged families through collecting new or used goods donated by private citizens or companies. The Arganil Social Shop operates in the Youth Activities Centre, organising different campaigns through volunteers.
